1 field = 40 going into endzone, so 2 scrimmages (4 teams) can go on one full field together.

Scrimmage format will be 20 minutes of offense each (40 minutes total) followed by 20 minutes Q&A with the officials.

• Review rules, sideline expectations, officials responsibilities – coverage areas

15-30 minutes is built in between each scrimmage. In either case, goal will be to move them along as quickly as possible. Please stick to a strict 20 minute running clock for each offense so we are not running over.

All teams should get one scrimmage. Hosting teams were given a 2nd scrimmage where odd matchups created the need. At Brighton and Webster, this creates a scenario where the last scrimmage of the day is occurring by itself. If other coaches want to discuss and have an unofficiated scrimmage on the open fields then that is fine.

Assigned officials will be paid at the 2024 rate (\$90/game). Candidates are expected to participate as part of their training program.

The assigned referees are to communicate with their crew prior to the scrimmage date as hey would for any game. Take attendance on game day of candidates, and also your crews attendance.
